March 31, 2022 REPORT ON HIGHER EDCATION EMERGENCY RELIEF FUND III FOR STUDENTS

The Higher Education Emergency Relief Fund III (HEERF III) is authorized by the American Rescue Plan (ARP), Public Law 117-2, signed into law on March 11, 2021, providing \$39.6 billion in support to institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic.

ARP funds are in addition to funds authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260 and the Coronavirus Aid, Recovery, and Economic Security (CARES) Act, Public Law 116-136. Emergency funds available to institutions and their students under all emergency funds total \$76.2 billion.

Selection criteria used by BCC to determine which students receive Emergency Financial Aid Grants and how much they would receive under HEERF III:

ARP: American Rescue Plan (HEERF III) Block Grants totaling \$113,100 were awarded for the Summer 2021 semester (\$300.00 - \$900): This allocation was awarded to students as a direct cash payment to help defray food costs and expenses associated with Internet and other utilities needed for remote learning. Awards were based on the number of weeks attended during the semester and the following student eligibility criteria:

- Enrolled in at least one 3-credit Summer 2021 course.
- Priority funding was provided to students who completed the 2020-2021 FAFSA with an Expected Family Contribution less than or equal to 6692 (BCC's 2020-2021 direct Cost of Attendance for a full year of full-time study).

HEERF III Emergency Applications:

ARP: American Rescue Plan (HEERF III) Block Grants totaling \$993,805 were awarded for the Fall 2021 semester (\$440.00 - \$1,000): This allocation was awarded to students as a direct cash payment to help defray food costs and expenses associated with Internet and other utilities needed for remote learning. Awards were based on the number of weeks attended during the semester and the following student eligibility criteria:

- Enrolled in at least one 3-credit bearing Fall 2021 course.
- Priority funding was provided to students who completed the 2021-2022 FAFSA with an Expected Family Contribution less than or equal to 6692 (BCC's 2021-2022 direct Cost of Attendance for a full year of full-time study).

ARP: American Rescue Plan (HEERF III) Block Grants totaling \$479,485 were awarded for the Spring 2022 semester (\$400 - \$785): This allocation was awarded to students as a direct cash payment to help defray food costs and expenses associated with heat and other utilities needed for learning. Awards were based on the number of weeks attended during the semester and the following student eligibility criteria:

- Enrolled in a degree program and at least
 6-credits for Spring 2022 course.
- Priority funding was provided to students who completed the 2021-2022 FAFSA with an Expected Family Contribution less than or equal to 6692 (BCC's 2021-2022 direct Cost of Attendance for a full year of full-time study).
