

# BERKSHIRE COMMUNITY COLLEGE PITTSFIELD, MASSACHUSETTS BOARD OF TRUSTEES MINUTES April 27, 2021

#### 1. CONVENING

A meeting of the Board of Trustees of Berkshire Community College was held on Tuesday, April 27, 2021, remotely via Zoom. Chair Bowen called the meeting to order at 4:31 PM. Kim Brookman took the roll.

#### 2. APPROVAL OF THE MINUTES

Upon a motion duly made and seconded, it was VOTED unanimously, by roll call vote, to approve the minutes of the March 23, 2021 meeting.

#### 3. PRESIDENT'S REPORT

President Kennedy reported the following.

The ecology flag had flown continuously at BCC until the previous administration pulled the US out of the Paris Climate Agreement. On March 28, 2017 at 2 pm, a small group of the BCC campus community watched as our Security team lowered the ecology flag to half-staff. The flag has remained at half-staff for the past four years. With the new Biden administration rejoining the Paris Climate agreement, BCC's ecology flag was returned to full staff at a small ceremony on

this year's Earth Day on Thursday, April 22<sup>nd</sup> at 11 am. It was attended by current and former faculty, staff, students, alumni, and community members.

President Kennedy also talked about Governor Baker's visit to the Covid vaccination clinic at Paterson on April 22<sup>nd</sup>.

#### b. Student Spotlight - Monica Bliss

Geoff Tabor, Coordinator of Transfer Affairs/Articulation and Phi Theta Kappa Advisor was introduced by President Kennedy.

Mr. Tabor then spoke about and introduced Monica Bliss.

Monica is a theater and music major at BCC. She is also a mother, wife, opera singer, theater artist, and non-traditional student. She hopes to transfer to a four-year college as a theater major, and is passionate about preserving live theater as an art form. Monica believes that theater serves as an incredibly powerful tool of the people which can influence and change society. She also believes that theater reveals problems, and creates empathy which can resonate worldwide. Monica's goal is to lead a progressive theater company producing transformative work.

Monica is a Berkshire Honors Scholar; serves as PTK New England Region President, PTK Chapter President, SGA President, and PR Chair of the Massachusetts Student Advisory Council to the Board of Higher Education. Monica was one of 20 named, out of over 2,000 nominated, to the prestigious All-USA Academic Team, and received a \$5,000 scholarship. She was named a New Century Scholar (the only one in Massachusetts) from thousands of students nominated from more than 1200 students across the country. Monica will receive a \$2,200 scholarship for this award. Monica also won an Oberndorf Family Foundation Scholarship for International Officer Finalists.

Her interests also include writing, social justice, law, and politics.

#### c. EMSI Report

Interim Provost Adam Klepetar introduced Kyla Mallory and Mike Hall from EMSI. Kyla presented on the economic value of Berkshire Community College, an analysis of its economic impact and return on investment of education for the 2018-2019 fiscal year. The economic analysis measures how the institution affects the local economy. The investment analysis is a comparison of the costs and benefits to determine the return on investment.

- Credit students served = 2285
- Non-credit students served = 1941
- Total payroll/benefits = \$18.4 million
- Employees = 376
- Total tuition revenue = \$4.5 million

Operations Spending Impact - College payroll and other spending + ripple effects

- Added regional income = \$25.8 million
- Jobs supported in the region = 448

Student Spending Impact - Retained student spending + ripple effects

- Added regional income = \$1.8 million
- Jobs supported in the region = 35

Alumni Impact - Higher alumni earnings and increased business profit + ripple effects

- Added regional income = \$75.1 million
- Jobs supported in the region = 1193

#### **ECONOMIC IMPACT ANALYSIS**

#### **Total Impact**

- Total income added in the region = \$102.8 million
- Of region's GRP = 1.5%
- Total jobs supported in the region = 1675
- . 1 out of 49 jobs in the region

#### **INVESTMENT ANALYSIS**

#### Student Perspective

- Benefit: Higher future earnings = \$60.2 million
- Cost: Tuition, supplies, opportunity cost = \$8.8 million
- Benefit/cost ratio = 6.8
- Rate of return = 33.2%

#### **Taxpayer Perspective**

- Benefit: Future tax revenue, government savings = \$14.6 million
- Cost: State funding = \$19 million
- Present value benefits for Massachusetts taxpayers from increased future tax revenue & government savings = \$14.6 million

#### Social Perspective

- Benefit: Future earnings, tax revenue, private savings = \$169.3 million
- Cost: All college and student costs = \$32.1 million
- Benefit/cost ratio = 5.3

A question was asked, "How does BCC compare to other Massachusetts community colleges?" Kyla from EMSI responded that BCC is in line with other community colleges. Mike from EMSI said that BCC's return on investment is one of the highest he's seen.





#### 4. STUDENT TRUSTEE REPORT

Student Trustee Raul Villalobos reported the following.

- SGA has been reviewing and proposing some changes to the SGA Constitution. The idea
  is to give more students the opportunity to be involved in SGA.
- SGA is also working on a project called Shared Governance Structure which would benefit students, staff, faculty and administrators.
- Drs. DiThomas & Benjamin met with the SGA group to get a feedback regarding the Shared Governance Structure at BCC. SGA members Monica Bliss, Christina Briggs and Linsday McCarthy are participating in the Shared Governance workgroup on campus.
- SGA created a blog which is live on the BCC's website.
- New elections for Student Trustee will be coming soon, for the Fall Semester.

#### 5. FOUNDATION TRUSTEE REPORT

Trustee Kiely reported the following:

- Impact Report
  - o Mailed out in October
  - o Raised: \$21,021.00
  - Last year raised: \$29,278
    - Slight decrease due to Emergency Funding campaign where normal end of year donors gave earlier in the year to support our students.
- Alumni& Friends News 2021
  - o In Mailboxes by mid-April, followed by Spring Appeal in May
- Scholarships/Awards Night
  - o Foundation will give away approximately \$334,734
    - Increased from last year by about \$30,000
  - Awards Night with format and date is to be decided

  - We are grateful for the opportunity to establish this scholarship together with his family to honor his legacy and love for BCC and our students. The VP ended by giving COVID-19 and CARES Fund updates.

So far, 25,000 people have come through vaccine clinics at Paterson. Comptroller Saviski has been keeping track of the costs to the college for these clinics. BCC will be reimbursed 100% through FEMA/MEMA.

Chair Bowen then asked for volunteers to be on the Nomination Committee for the new Vice Chair. Trustees Chacon and Kiely volunteered.

Chair Bowen informed the Board that the Human Resources Committee would be meeting soon to prepare President Kennedy's and the Board's evaluations. A survey will go out soon for the Board members to complete.

The Chair said she was looking at having a Board Retreat in late summer or early fall.

The meeting was adjourned at 6:06 PM. The next scheduled meeting will be held on June 1, 2021.
